FIRE PERMIT – APPROVAL IN PRINCIPLE

1. The underlisted documents on your proposed **EDUCATIONAL COMPLEX** at **KWABENYA** has been received by the Safety Directorate for approval in principle: -
 - a. Fire Protection Installation Proposal
 - b. Drawing of facilities to be constructed on site and Fire Plan
 - c. Application Form B
 - d. Payment of prescribed fees
2. The Fire Safety Department is satisfied with the Fire Fighting facilities and fire alarm system proposed for installation in the report.
3. The Fire Inspector shall monitor to ensure that the facilities mentioned under Section '2' above are implemented.
4. A Fire Certificate will be issued by the Chief Fire Officer/Representative when the Service is satisfied with installation and functioning of the Fire Protection Facilities stated in the conceptual report after the final inspection has been conducted and submission of compulsory Fire Insurance Sticker from National Insurance Commission (NIC).
5. Acquire a compulsory Fire Insurance cover indicated under section 183 of the Insurance Act 724, 2006 when the project is completed.
6. Copies of the drawing and report shall be made available to the contractor(s) etc for compliance.
7. Submit a copy of the final drawing to the office.
8. Approval in principle is hereby given, permit or clearance be granted by the appropriate agency to allow the project to proceed if the zoning status supports the development but in compliance with what have been stated in the conceptual report.
9. The Fire Permit (approval in principle) is valid for twenty-four (24) months from the date of issue and subject to renewal for fee provided in schedule 4 of the Legislative Instrument (LI) 1724.
